**Office Order (Revised)**

In continuation to this office Order of even number dated 13<sup>th</sup> April, 2021, Director, CIRB, Hisar has been pleased to approve and finalize the following policy to disposal of surplus bulls at CIRB, Hisar as well as Sub Campus, Nabha:-


**Category of bulls to be sold from ICAR-CIRB:**

1. Breeding bulls whose Dam's yield is more than 3000 kg in a standard lactation (As per MSP standard) which were used under Network Project on Buffalo Improvement (NPBI) for semen collection for a period of 1.5 years or more and required number of semen doses have been collected.
2. Bulls whose dam's yield is more than 3000 kg but were not selected under NPBI due to other reasons.
3. Bulls/ young males whose dam's yield is less than 3000 kg.

**The following policy will be used for the sale of bulls under different categories:**

1. List of bulls for sale along with their book values will be made available on the website of the ICAR-CIRB from time to time.
2. Interested organisations/ agencies/ parties for the purchase of bulls having dam's yield of more than 3000 kg will be asked to send their request (on E Mail to Director, ICAR-CIRB) within one month of publishing the list of bulls on Institute web site.
3. Among the requests received; first preference for selling the bulls on book value will be given to Govt. organizations engaged in semen freezing activity on first come first serve basis.
4. In case no application is received from any Govt. organization within the stipulated date, the bulls will be offered for sale to the applications received from registered NGOs/ private agencies engaged in semen freezing activity. For registered NGOs/ private agencies the bulls will be sold with a minimum price of 1.25 times of the book value.
5. In case bull purchase requests are received from more than one party (registered NGOs/ private agencies engaged in semen freezing), bidding will be done among them over and above 1.25 times of book value for individual bulls.
6. If no demand is received within one month from any Govt. or private agencies engaged in semen freezing, the bulls will be made available for sale on book value to Govt. organization/ gram panchayats/ individuals for its use in natural breeding on first come first serve basis.

7. If the bulls still remain unsold, then it will be sold through public auction along with other animals.
8. Bulls initially selected under NPBI but later found unsuitable for any health/ reproduction abnormalities or any other reason/s will not be sold for breeding purpose. These bulls will be culled through open public auction after recommendation of empowered committee constituted for the purpose, along with other surplus culled bulls/ males.
9. Bulls/ young males under the category 3 i.e. whose dam's yield is less than 3000 kg will be sold on book value and on first come first serve basis to the development agencies/ individuals for breeding purpose.
10. Bulls/ males which remain unsold in any category will be sold through open public auction.
11. The book value will be effective on the actual date of purchase.
12. The decision of Director, ICAR-CIRB, Hisar will be final to accept/ reject any offer without assigning any reason.
