- address as given by the candidates. These shortlisted candidates will undergo a panel interview at ICAR-CIRB, Hisar. Candidates are advised to clearly mention their active email IDs.
- 3. The appointment of selected candidate will be subject to the condition that he/she is declared medically fit for service by the prescribed medical authority.
- 4. There is no need to send hard copy of the application and only the applications received through email at the given email ID will be entertained. However, the candidate should bring hard copy of duly filled in application form alongwith CV and a passport size photo and other attested certificates at the time of interview, if found shortlisted and called for interview.
- 5. The applicants must bring with them the original documents alongwith experience certificate(s) if any, at the time of interview.
- 6. No TA/DA will be paid to the candidates for attending the interview.
- 7. Eligible candidates who are called for interview will be required to be present at least 30 minutes before scheduled time on the date of interview for completing necessary formalities.

#### Other Terms and Conditions

- I. The position is purely temporary and will be filled on contractual basis as per need initially for a period of one year. However, duration of engagement can be curtailed/extended as per need and subject to performance of the candidate.
- II. The engagement will not constitute a regular job or appointment of any nature in the ICAR/CIRB.

- V. The selected candidate will be stationed at ICAR-CIRB, Hisar and have to attend laboratory/field and office related work at this Institute.
- VI. Candidate should be willing to complete the allotted work in time. Work may be allotted based on the requirements rather than the expertise of the candidate.
- VII. The working hours will be same as regular employees of ICAR. No extra benefit will be allowed for working beyond office hours. Unauthorised absence from the work for a continuous period of 08 days without valid reasons shall lead to automatic termination of the engagement.
- VIII. The Young Professional shall have to comply with the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013.
