5. Applicants will be shortlisted based on their qualifying academic performance as per an assessment criterion. The short listed candidates will be informed by this office through the email address as given by the candidates. These shortlisted candidates will undergo a panel interview at ICAR-CIRB, Sub Campus, Bir Dosanjh, Nabha (Punjab). Candidates are advised to clearly mention their active email IDs.
6. The applicants must bring with them the original documents alongwith experience certificate(s) if any, at the time of interview.
7. No TA/DA will be paid to the candidates for attending the interview.
8. Eligible candidates who are called for interview will be required to be present at least 30 minutes before scheduled time on the date of interview for completing necessary formalities.
9. Applicants are advised to keep visiting website of this Institute for any corrigendum/update.
10. The engagement of selected candidates will be subject to the condition that he/she is declared medically fit for service by the prescribed medical authority.

Other Terms and Conditions

- I. The positions are purely temporary and will be filled on contractual basis as per need initially for a period of one year. However, duration of engagement can be curtailed/extended as per need and subject to performance of the candidate.
