2. The enlistment of the contractors should be valid on the last date of submission of bids. In case only the last date of submission of bid is extended, the enlistment of contractor should be valid on original date of submission of bids.
3. The bidders have to deposit EMD i.e Rs.15,000/- in the form of DD/BG/FDR in favour of Director, ICAR-CIRB, Hisar at the time of participation in bid. EMD refundable upon completion of work. Bank details given below:

4. The work is estimated at a cost of Rs. 5,11,768/-. This estimate, however, is given merely as a rough guide.
5. The Director, ICAR-CIRB, Hisar reserves the right to accept or reject all or any of the quotation in part or full.
6. The purchaser will evaluate and compare the bids which are substantially responsive i.e. which are properly prepared and signed and meet the required terms and conditions, specifications etc. The purchaser will award the contract to the bidder whose bid will be determined to be responsive and offers the best evaluated price.

7. Successful quoter/bidder has to deposit 5% amount of the total cost of the inspection and repair work as Performance Security money in the form of DD/BG/FDR in favour of Director, ICAR-CIRB, Hisar etc.
8. The payment will be made on completion of satisfactory installation.
 - I. Bid shall remain valid for acceptance for a period of not less than 90 days after the specified date of opening of the order.
 - II. The firms on whom the work order is placed with in the period of validity of the offer will be required to execute the works within the time limit given above from the date of issue of the work/contract order.. If the bidder fails to deliver any or all of goods/services, the purchaser shall deduct from the contract price as liquidated damages a sum equivalent to 0.5% of the delivery price of the delayed goods for each week of delay. The maximum limit of such deduction will be of 10% of service contract/bid price. Once the maximum is reached the contract will be considered terminated of the contract automatically, if the same have not been terminated already.
9. **The firms are required to upload copies of the following documents:-**
 - a) Registration Certificate of the firm with the appropriate State/local Government.
 - b) Contractor should be registered with CPWD, MES or any other Public Works organization /undertaking of Govt. of India or State Govt.
 - c) Last two year continuous experience of the firm in the field of providing such services/works in Central Govt. establishments/Autonomous bodies of Govt. of India/Corporations of Govt. of India/reputed public or private Govt. of India/Corporations of Govt. of India/reputed public or private organizations. Provide the details in enclosed tabular form.
 - d) Duly certified copies of the satisfactory services where the tenderer is providing the services for the last two years.
 - e) EPF registration certificate issued by concerned authority.
 - f) ESI registration certificate issued by concerned authority.
 - g) GST registration certificate issued by Govt. etc. without GST No. quotation will be rejected straight way.
 - h) Scanned copy of proof of EMD submission.
 - i) Bidders are advised to visit the site for physical inspection before quotation their rates. Sites can be inspected by the bidders on any working at 11:00 AM onwards during 18-11-2024 to 03-12-2024.
10. An undertaking to the effect that firm/supplier/contractor has not been blacklisted/ debarred by any Govt. department/ Public sector undertaking during last 3 years.
